New Trauma Program at The House Next Door

At the end of June we were contacted by Children's Medical Services in Tallahassee and asked if The House Next Door would assume responsibility for the local **Sexual Assault Treatment Program (SATP)**. The program focuses on trauma therapy; services were previously provided by the Children's Advocacy Center in Daytona Beach. Our agency accepted the contract and on July 1, The House Next Door began accepting referrals for the **Sexual Assault Treatment Program**.

The statistics are alarming:

- One in four girls will be sexually assaulted before the age of 18
- Child sexual abuse can include non-contact abuse, such as exposure, voyeurism, and child pornography
- One in six boys will be sexually assaulted prior to age 18
- 9.3 percent of the 3 million nationwide reports of child abuse are sexual abuse
- In the past year, 1 in 5 youth were approached or solicited over the Internet
- Children with disabilities are 40 times more likely to be victims of sexual abuse
- This year, about 400,000 babies born in the US will become victims of sexual abuse unless we do something to stop it

This service helps individuals, both child and adult, in effectively coping with the trauma of sexual assault. All SATP therapists are trained in trauma informed care, evidence based treatment methods including Trauma Focused Cognitive Behavioral Therapy (TF CBT). The precipitating event may be a current incident or one that has occurred in the past and is unresolved.

The *Sexual Assault Treatment Program* is jointly funded by the Office for Victims of Crime and Children's Medical Services.

The House Next Door has been providing family therapy and support services since 1976. Staff is trained to be welcoming and helpful. The therapy process recognizes individual and family culture, values and goals, and accommodates variations in lifestyles, with emphasis on healing, coping and personal development.

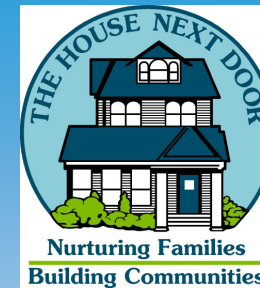
